If you are an Arizona taxpayer, you can take advantage of the Arizona Tax Credit Program, a dollar-for-dollar return on your Arizona state tax when you make a contribution to a qualified charitable organization – like RGR.

## Earn valuable state tax credits when you give to Reigning Grace Ranch

Reigning Grace Ranch (RGR) is proud to be a part of the Arizona Tax Credit Program. As a Qualifying Charitable Program, your donations to RGR will qualify for the Arizona Tax Credit program. The Arizona Tax Credit Program allows individuals and couples to make a contribution to a Qualifying Charitable Organization and increase the amount of your state refund or decrease what you owe. Anyone who pays Arizona state taxes, whether you itemize or not, single or married, can qualify for the Tax Credit of up to \$800 for couples filing jointly or \$400 for individual taxpayers.

These tax credits provide dollar-for-dollar tax benefits, allowing taxpayers to reduce their state tax liabilities for each dollar donated to charities, up to the maximum allowable limits.

## Is the deadline for contributing April 15th?

The deadline for making a donation to a Qualifying Charitable Organization is April 15, 2020.

## How do I file my tax credit?

Use Arizona Form 321, "Credit for Contributions to Qualifying Charitable Organizations" to claim your tax credit.

The tax ID for RGR is 45-3219899 and the AZ Tax Credit Code is 20757.

## What if I currently use the Public Education Tax Credit?

You can claim both on your tax return. The Arizona Charitable Tax Credit is independent from the Public Education Tax credit.

## Can I use the Charitable Tax Credit on my Federal income tax returns?

The Charitable Tax Credit may be applied to your Arizona State income tax. In addition, donations to RGR filed by the year-end may also qualify for a federal tax deduction for the amount donated.

## Arizona Charitable Tax Credit Guidelines

The following are general guidelines for using the Arizona Charitable Tax Credit. As always, please consult your accountant or tax advisor for advice on your specific tax situation.

- Donations must be made by individuals (corporations, foundations, partnerships, etc. do not qualify).
- Donations must be made in cash (property donations do not qualify, nor do in-kind donations such as toys, books and services).
- Donations must be made to Qualified Charitable Organizations or Qualifying Foster Care Charitable Organizations that have been certified by the state of Arizona.
